

## Completed reviews

The following list sets out applications on which Te Kāhui has decided to take no action or no further action, and sets out the reason for that decision. In deciding whether to progress a case, Te Kāhui must consider if it is in the interests of justice to do so. This a statutory test set out in section 17 of the Criminal Cases Review Commission Act 2019.

This data is published pursuant to section 26 of the Criminal Cases Review Commission Act 2019, and is released for statistical purposes. It is provided on an anonymised basis in order to protect the privacy of all those involved in the case, including applicants, victims, and other third parties who may have played a role in the case or the application. This anonymisation is consistent with section 35 of the Criminal Cases Review Commission Act 2019 which prohibits Te Kāhui from releasing information about its cases unless one of the exceptions in section 36 applies.
